## **Requirements for invoicing**

- 1 The designation "invoice" or "credit note" must be included on the document. Commercial credit notes, such as correction documents, should not be labeled as credit notes but as cancellations or corrections
- 2 Correct designation of the invoice recipient (see attachment). This also applies to invoices from abroad. The name of the buyer can additionally be mentioned after the company name
- 3 Consecutive invoice number and invoice date
- EagleBurgmann order number or cost center and name of the buyer
- 5 VAT identification number (VAT ID no.) or tax number of the respective EagleBurgmann entity (see attachment)
- Exact and comprehensible details of service / delivery (usually identical to the order regarding position, item / service, date of service / delivery, net unit price)
- The fee (net amount) separated by tax rate and tax exemption, as well as any reduction in payment agreed in advance (discounts, bonuses or rebates) and the total amount including the currency in ISO code (e.g., EUR, USD, GBP, etc.)
- 8 If applicable, reference to any tax exemption (e.g. intra-community delivery) or reverse charge procedure
- 9 Payment deadline and other conditions
- 10 Full name and address of the supplier, as well as corporate information
- Bank details and tax number or VAT ID no. of the supplier (for invoices from other EU countries, the VAT ID no. must be provided)
